

MARINA BAY - SECOND SLIP REQUEST 2010

Over the last few years we have had a few homeowners who have requested a second slip for their own use. We anticipate that we may have a few slips available for this year after we have filled all Homeowner's requests for a slip and met our lease requirements to the Sylvan Lake Sailing Club.

These second slips will be for the 2010 boating season only. We will look at the availability of extra slips on a yearly basis. If you had a second slip last year you are not guaranteed to have the same or any slip for this year. If we have more requests for a second slip than slips available we will do a draw at the AGM to choose who receives the second slips. The availability of second slips is becoming very limited and cannot be assured. Requests for a third slip will not be entertained until all first and second slip requests are met.

The cost for the second slip will be at the rate we charge the Sylvan Lake Sailing Club which is \$930.00 + 5% GST=\$976.50 for 2010. Only vessels registered to a Marina Bay Homeowner will be accepted for a second slip assignment. ***We are trying to accommodate Marina Bay Homeowners who may have purchased a second vessel for their own use. This is not for homeowners to provide a slip for friends or relatives. If a homeowner breeches this policy the Boar has the authority to withdraw the Homeowner's privileges to use the Marina and facilities.***

In order to be fair with the allotting of these slips, we will accept applications for a second slip only until March 1, 2010. **Your application must be accompanied by a cheque for the amount of \$976.50** made payable to Sim & Thorne and a copy of proof of ownership of the vessel you wish to dock in the second slip. If you have previously had a second slip and have provided a copy of proof of ownership, you do not need to provide it again as we have it on file.

You will be notified at the May 22nd AGM if you have been assigned a second slip. If you do not have your request filled, your cheque and proof of ownership will be returned.
